YMCA Camp Mohawk, Inc. is an independent YMCA membership organization. All campers must be a member of YMCA Camp Mohawk in order for their application to be accepted and must hold current membership through the end of their stay at camp. The annual membership fee is \$10.00.

Registration deposit of \$200.00 per session plus all riding fees and \$10.00 membership fee must accompany this registration. This fee is applied to total fees due.

1. I give permission for my child to participate in any activities, either on or off camp property (including bus trips) for which she may qualify under camp standards. I recognize that there are inherent risks in most camp activities.

2. I understand that the camp has the right to dismiss any camper, if necessary, for the good of the camp.

3. Any cancellation received in writing or email (info@campmohawk.org) **prior to May 1st 2008** (April 1st 2008 for Equestrian Camp and Senior Cape Cod program participants) will result in a refund of all fees paid minus the \$200.00 deposit regardless of reason of cancellation.

4. **Prior to attendance:** NO REFUNDS will be made for cancellations received **after May 1st 2008** (April 1st 2008 for Equestrian and Senior Cape Cod program participants) except in cases of documented medical reasons. In the event of documented medical reasons for cancellation, a refund will be issued for 50% of fees paid after the deposit has been subtracted.

5. Once a child has begun her camp experience, no refund will be issued for any part of camp fees paid if the child leaves camp before the session(s) she is registered for are completed except in the case of a documented medical reason. Any camper withdrawn from camp for reasons related to homesickness will not be issued a refund. In the event of a documented medical reason other than those related to homesickness, a refund will be issued for 50% of the prorated fees minus the deposit.

6. **Riding Fees:** If inclement weather results in a camper being unable to ride for more than two days in a one week period, a refund equal to 1/5 of the weekly riding fee paid will be refunded upon request for each subsequent day that a riding lesson participant cannot ride due to weather related causes.

7. If you are uncomfortable with the above Refund Policy, please consider camp cancellation insurance or perhaps another camp program. Information about camp cancellation insurance is available at www.mycamp protector.com or www.travmark.com.

8.
