Terms and Refund Policy

- I give permission for my child to participate in any activities, either on or off camp property (including bus trips) for which she may qualify under camp standards. I recognize that there are inherent risks in most camp activities.
- I understand that the camp has the right to dismiss any camper, if necessary, for the good of the camp.
- Any cancellation received in writing or email (info@campmohawk.org) **prior to May 1, 2024** will result in a refund of all fees paid minus the \$200 deposit regardless of reason of cancellation.
- Prior to attendance: NO REFUNDS will be made for cancellations received **after May 1, 2024** except in cases of documented medical reasons. In the event of documented medical reasons for cancellation, a refund will be issued for all of fees paid minus the deposit.
- Once a child has begun her camp experience, no refund will be issued for any part of camp fees paid if the child leaves camp before the session(s) she is registered are completed except in the case of a documented medical reason. Any camper withdrawn from camp for reasons related to homesickness will not be issued a refund. In the event of a documented medical reason other than those related to homesickness, a refund will be issued for prorated fees minus the deposit.
- In the event that Camp Mohawk must close per state or federal regulations regarding COVID-19, a full refund, including the deposit, will be issued.
- Riding Fees: If inclement weather results in a camper being unable to ride for more than two days in a one week period, a refund equal to 1/5 of the weekly riding fee paid will be refunded upon request for each subsequent day that a riding lesson participant cannot ride due to weather related causes.
- Horseback Riding: I understand that horseback riding is an inherently dangerous activity with the possibility of falls and serious injury.
